Memorandum for All MIWG CAP Members

From: MIWG Director of Emergency Services

Subject: Getting involved in your personal training track in Operations Specialty Qualifications

1. It is our hope that this memorandum may guide any Michigan Wing (MIWG) Civil Air Patrol (CAP) member as you begin (or revisit) their Emergency Services (ES) Training. We have attached several documents that we hope can help you along as you reach your desired (or recommended) level of Operations Specialty Qualifications (OPSQUALs).
2. The MIWG Emergency Services staff recommends that each member strive to achieve at minimum the OPSQUAL equivalent to their Squadron, Group, and/or Wing Duty Assignments. If you haven't already begun your OPSQUALs training and/or need to refresh or restart the process we recommend the below steps:
 - a. Complete [Level I \(Senior Members\)](#) or the [Curry Achievement \(Cadets\)](#)
 - i. It is highly recommended to NOT start training in OPSQUALs until you complete the important first step of your overall CAP Training.
 - b. [Complete General Emergency Services Training through National](#)
 - c. [Complete FEMA ICS 100, 200, 700, and 800 training](#)
 - i. Be sure to upload your course certificates to E-Services Operations Qualifications Module and submit data into any Specialty Qualification Training Record (SQTR) worksheet associated with these or other courses taken. See attached "Training Resources - Links of Importance to all MIWG Members for ES Training" document for screen shots of where these are.
 - d. Work through a Skills Evaluator (SET) at Unit or Group level to achieve at least one initial tactical Level qualification. These "entry level" specialties would include either Urban Direction Finding Team Member (UDF), Ground Team Member Level 3 (GTM3), and/or Mission Scanner (MS). Cadets must be at least 18 years of age to become a Mission Scanner (MS).
 - e. Work through a Skills Evaluator (SET) at Unit or Group level to achieve the Mission Staff Assistant (MSA) Qualification.
 - f. Work through a Skills Evaluator (SET) at Unit, Group, or Wing level to achieve an operations qualification (OPSQUAL) that matches your assigned Job Duty(s).
 - i. See attached "Job Duty to Operations Qualifications (OPSQUAL) Minimum Equivalency Training Goal"
 - ii. Note: Being in a Job Duty at the Squadron, Group, or Wing level does NOT automatically make you qualified to serve on Air Force Assigned Missions (AFAMs) in that duty area. In order to serve in a job area on an AFAM, you must hold the qualification in at least a trainee level on your 101 Civil Air Patrol Specialty Qualification Card listed in e-services.
 - iii. If needing assistance finding an SET, contact MIWG ES Training Officer (DOST).
3. If you need any assistance for anything that can not be resolved at the Unit/Group level, please do not hesitate to reach out to the Wing Level. All Wing Staff are here to serve you at the local unit levels at any point we can!
 - a. Attached is the current roster of Operations and ES Staff at Wing Level.
